Proposed: An Accelerated Learning Center - Genius Kids

Location: Hacienda Business Park, 5698 Stoneridge Drive, Pleasanton CA 94588

The new Genius Kids Accelerated Learning Center & Day Care is proposed to be located at 5696 Stoneridge Drive, Pleasanton CA 94588, the existing Hacienda Business Park Building A, located at the corner of Stoneridge Drive and Gibraltar Drive.

Genius Kids will occupy the space referenced above, which to the best of our knowledge, was formerly used as a book store, and is currently vacant, adjacent to a convenient food mart. The space is approximately 4,626 square feet, and we plan to reconfigure it internally to meet daycare requirements set by the Department of Social Services of California (referred to as DSS in this document), as well as current Fire and Building Codes.

The learning center & day care will be located on the ground floor, with easy access to ample parking at the front and side of the building, including accessible stalls. The school playground will be placed at the right side landscaped portion (facing Stoneridge Drive) of the space, to include approximately 4,000 square feet of outdoor space as mandated by DSS - refer to plans as shown on plan attached. No parking is being affected. The play is being designed safely with secure fencing using both the existing hedges, and green screening to allow for privacy from all angles.. The fences will have screens to ensure the children are not visible, including gates with the appropriate panic hardware to meet current fire and building codes. A sample of the renderings from Playgrounds Unlimited, professional playground designers is included.

The interior of the building is being modified to minimum to include 8 preschool 8 toilets & sinks, for ages 2-6 as per the ratios of 1:15 mandated by DSS for a licensed facility of approximately 90 children. The space has ample windows to provide light to the various classrooms. A water fountain will be installed inside the facility.

A small lobby or drop off area in the front lobby using pony walls, and beautiful decorated spacious classrooms with life size animal murals, motivational words and posters (see pictures included).

The Preschoolers ages 2-6 and under will have no bell times and will be dropped off and picked up anytime between 8 AM through 6:30 PM. We envision peaks of these to be between 8:30 - 10:00 AM, and between 5:00 - 6:30 PM.

We will operate 2 school vans which will pick up the After School students from the local schools reducing the drop off traffic times during the school hours. Our vans will be parked in the side parking spaces of the building at all times, except for the drop off times where students will be dropped off and escorted into the building from the front entrance.

Parents will always park their cars in the respective parking spaces, and bring their children to the classroom doors. Mandatory sign in and sign out procedures are enforced. There will be no UN-attended children in the parking lots or playground areas.

Signage will be consistent with the Hacienda Business Park signage program and a drawing of the sign will be submitted to the city of approval.
