#### Little Ivy League "LIL" Preschool Conditional Use Application Business Description

Applicant: Jennifer Zheng, 3728 Appian Street, Pleasanton, CA 94588

Proposed School Location: 4160 Hacienda Drive, Suite 100, Pleasanton, CA 94588

**Summary:** 

The Little Ivy League (LIL) is a California non-profit corporation. It currently operates a "Heritage School" at 4160 Hacienda Drive offering academic and Chinese culture enrichment classes to elementary school students and tutoring services to middle school students. It is LIL's desire to open a day care center for preschool children at the proposed location.

The building located at 4160 Hacienda Drive is a commercial standalone building (total 23,168 square feet) that is owned by Balch Enterprise, consists of two units: Suit 100 of 15,934 square feet and Suite 200 of 7,234 square feet.

In this petition, LIL seeks a CUP for its Preschool operations in Suit 200 at 4160 Hacienda Drive with a maximum capacity of 120 students. Concurrently with this application, LIL also submits a separate petition to amend CUP # P11-0938, the CUP currently in effect with respect to 4160 Hacienda Drive for its Heritage School, proposing to reduce its Heritage School capacity to 180 and to limit the Heritage School operations to Suite 100.

LIL Preschool will be a fully licensed day care centers center. In compliance with the regulations governing the licensed day care centers in California, LIL Preschool will be staffed with no less than a ratio of 1:8. LIL proposes a maximum capacity for 120 children at this center. As such, there will be maximum 12 care staff and 3 administrative staff for the LIL Preschool operations running at its maximum capacity.

LIL will comply with all the statutory and regulatory requirements concerning the physical site plan and staff qualifications imposed and enforced by the California community-licensing agency. LIL Preschool will obtain and maintain the required childcare license to start and maintain its operations.

#### **Facility**

The proposed facility is at 4160 Hacienda Drive. This is a 23,168 square feet stand-alone building, divided into Suite 100 of Suit 100 of 15,934 square feet for heritage school and Suite 200 of 7,234 square feet for preschool. The facility also includes 10,000 square feet green areas, and an outdoor patio area. 3,450 square feet of the green area and outdoor patio will be used as outdoor playgrounds for LIL Preschool.

A floor plan and a site plan are attached as Exhibit 1 hereto, showing the spaces devoted for LIL Preschool and its reception area, administration office, classrooms, and storage and outside playgrounds (Playgrounds B1 & B2).

#### Hours:

With the extended care program, the LIL Preschool Child Care Center operates from 7:00 a.m. to 7:00 p.m. daily, Monday to Friday.

7:00 a.m. to 8:00 a.m.: Extended Care 8:00 a.m. to 6:30 p.m.: Day Care 6:30 p.m. to 7:00 p.m.: Extended Care

#### **Programs:**

LIL Preschool offers modified Montessori based preschool programs for Toddlers up to the Kindergarten ages. The programs are by the age group:

<u>Pre-K 2-Year Old</u>: This group has 2-year olds to 3-year olds. At this age, teachers will have students begin experimenting, and interacting with other children and the environment. More routine and structure are introduced into the daily schedule. Students will start to learn how to find uses for familiar objects, and how to explain everyday occurrences using simple reasoning.

<u>Pre-K 3-Year Olds</u>: This group is for 3-year olds to 4-year olds. Three-year-olds are more secure, and ready for a higher level of challenge. In this group, a series of fun and learning activities are designed to continue to instill students with the knowledge and skills necessary to succeed at the next level. Skills learned during

this period include recognizing letter names, catching a bounced ball and beginning to understand the concept of yesterday, today and tomorrow.

<u>Preschool/Kindergarten</u>: This is for 4 to 6 years olds. Pre-K students will learn letter-sound relationships, how to sound out unfamiliar words, and how to read and recognize sight words. They will learn match concepts such as greater than, less than and equal to, and their number sense will grow. Pre-K students will also learn to make predictions based on prior knowledge, delve into traditions of other cultures, and will learn to write all uppercase and lowercase letters.

Our Kindergarten program¹ includes foundational literacy and math skills derived from the Common Core State Standards. Teachers will give students the strong foundation they need for future success. Our well-rounded curriculum builds sound reading, writing, and math and problem-solving skills. Some of the skills acquired at this level include creating and interpreting data in bar and pie charts, counting by 5s and 10s, and matching familiar spoken words to written words.

#### **Outdoor Playgrounds**

There are two outdoor playgrounds dedicated to LIL Preschool—Playground B1 and Playground B2. Students will play at outdoor playground twice a day; and divided into 60 students each group rotating for the use of the playgrounds.

#### **Traffics:**

All students will be dropped off and picked up by parents; and there will no pickups by ILI Preschool.

The current CUP allows maximum capacity of 300 students or heritage students. If approved, there will be maximum 120 students for LIL Preschool and 180 students for LIL Heritage School. There will be around 50% of the Preschool students who are siblings of those who are already attending Yang Fan Heritage School.

As such, with the total capacity of 300 students for the entire site at 4160 Hacienda unchanged, LIL Preschool will not significantly change the traffic volumes at the peak hours.

The following chart shows the projected traffics for the entire sites including LIL Preschool and LIL Heritage School during the school year:

#### **Parking**

The proposed facility has total 150 parking spaces available for daily use. Based on the estimation concerning the traffics and transportation, there are more than sufficient parking slots to sustain both Preschool operations and modified Heritage School operations.

Furthermore, with the modified CUP for Heritage School reducing its capacity by the total number of students allotted for Preschool, the new Preschool operations will NOT increase the need or parking capacity for the site.

No commercial regular pick up or delivery services are required for our school.

#### Child Care License Will Be Obtained and Maintained:

A license for childcare center will be obtained and maintained for LIL Preschool at all




