TO WHOM IT MAY CONCERN:

Barone's Restaurant has been in operation in downtown Pleasanton for over fourteen years. We are a full service, fine dining restaurant and are open for food service on a daily basis. Over the last fourteen years we have served lunch and dinner seven days a week. Currently due to economic times, we have shortened our hours and now open daily at 4:00pm for dinner service. We employ about 30 full time/part time employees. We currently have a conditional use permit on the property, which was put into place in 1988. The reason for our proposed amendment is to update the current permit to include music in our outdoor areas and extend the hours.

This is a new feature of our business, initiated to offset declining business due to the recession. We will want to maintain as much breadth as possible regarding the types of entertainers while we develop this market. We will be having a variety of entertainment, which may occur at any given day of the week. Examples of potential entertainers would include live bands, Disc Jockeys, Ipod and/or CD music, stand up comedy night, a winemaker dinner (with commentary from the winemaker), corporate groups, that might have a speaker, and the like. Generally, we plan to select the music to go with the event theme, if there is one. There will be events however, like weddings in which the customer selects the music and/or musicians.

The back patio and the front patio can each accommodate music, though of course the front patio would be for smaller groups. The "dance floor" on the rear patio is on concrete. When music is playing, people do get up and dance on the patio. We monitor noise levels as owners and managers. Our stage and amplified music is strategically positioned so that our music faces Main Street and away from the town homes. This stage is permanent in the sense of being left up continuously, and it is 16 inches high.

We hope to have outdoor food service (weather permitting), including music, as part of our regular operations. If the market allows, we would hope to have outdoor service most evenings. In thinking more precisely about the hours, we would prefer to have outdoor music until 10 p.m. on Sunday through Thursday, and until 11 p.m. on Friday and Saturday. Although there is no customer demand for a full menu after 9 or 10 o'clock, we would like to have the flexibility to remain open nightly until 2:00am, providing limited light foods, snacks and/or appetizers.

Although we currently don't serve lunch, we want to keep all options open during daytime hours, including lunch and breakfast if the opportunity presents itself. During evening hours, we could have events continue on until the statutory closing time. We feel this will benefit not only our business, but also all of the other businesses in the surrounding areas. We have a wonderful reputation with the community and run a professional and well-respected business. Thank you for your considerations.



Subject: BARONE'S CONDITIONAL USE PERMIT

Dear members of the City Council and Mayor,

Apparently, Barone's has been issued a conditional use permit for outdoor music without any public input. Apparently, the condition Barone's was given the permit was on the premise that the Pleasanton Hotel had previously had a permit before they went out of business, therefore, they were entitled to a permit. There was no public notification of any kind.

While it is indeed true that the Pleasanton Hotel did have a permit, the Pleasanton Hotel complied with strict guidelines after receiving citations for their noise. Last night the band at Barone's exceeded all noise limits. The racket overrode the sound of our t.v. set and my whole home vibrated with the loud drum beats. There was not one room in my home where I could find sanctuary. It was hot and it was impossible to open the windows without being inundated. I did call Barone's and subsequently the Pleasanton Police. Officer Paulson spoke to Barone's and informed me they had a conditional use permit. In response to my complaint, the music was turned down to a measurable 65 decibles 20 feet from our property line. On week nights, the Pleasanton Hotel, would cease all music promptly at 10 p.m. on week nights and the loudness was controlled. While the band at Barone's stopped playing prior to 10 p.m., they switched to piano music which they continued to play after 10 p.m.

This is not our first encounter with noise from Barone's. They have installed a sound system around the peritmeter of their home. They would play loud music at all hours of the day. When we spoke to them, the excuse given by Mrs. Barone was that her child was hearing impaired. That issue was finally resolved when I countered with my own music...the sound of trains. I was working nights at the time and needed to sleep during the day. Before I retired, I was forced to sleep on a mattress in my closet to find quiet I needed to function on my job as a nurse at UCSF.

We know we live downtown and must endure the sounds of the City, however, I believe there are parameters with which a business must comply. In our own establishment at 780 Main Street, noise was always a concern for our neighbors. We will be selling our home but now I fear I will be unable to sell because of the racket indiscriminately played for their own needs. I do not want to prevent a business from marketing in these difficult times, however, we homeowners have not been considered or allowed to voice our issues before the condtional permit was issued.

Thank-you Officer Paulson for responding last night. There was not much he could do with out seeing the conditional use permit but he did promise to secure the information today. Officer Paulson also shut down the music at 10:20 p.m. I too will seek information regarding the parameters of the conditional use permit today. I am really concerned because there was no community input..

Maybe, I am in error and if that is the case, I will cease my complaints and quietly leave. I too have a disability and indescriminate loud nose is an aggravation. Fortunately, Mrs. Barone, the mother of Joe Barone is hard of hearing and can simply remove her hearing aide. I have asked the Barone's in the past to give us notice of their events so we could seek a hotel room but we have not even been given that consideration.

Dear City,

Thank-you for your response to my questions regarding a use permit for the downtown businesses. As I have declared in past correspondence, I do not wish to prohibit music in our downtown area. I am interested in developing parameters in the current permit that was issued without any public input on July 17th, 2008 without any public input (the same day I called to complain).

It is obvious Barone's will not stop their music until they are called or the police notified. I am still concerened. Last night I called @ 9:15 p.m. at which time Barone's promptly turned off the music. I do not understand why I have to call at all. The permit issued to the downtown on July 17th: Mr. Barone was given a copy of the permit. After listening to the racket for four hours, I was not in the mood to listen an hour longer. There is not one place in my home to find sanctuary. I can only imagine what the decible reading was at the origin. It seems a health issue if the noise is so loud that hearing can be impaired in the establishment. We are now considering selling our home just as several neighbors have done in the past and/or installing soundprood walls and windows to the exterior so no further devaluation will occur. We have been here for 21 years.

It seems a little late for the Planning Dept. to assure us there will be input to the Temporary Use Permit ONLY if Barone's asks for a new use permit or if an alteration is made to the current permit. Why wasn't public input allowed for the permit issued so promptly to Barone's on the day I called to complain? Is it because Barone's have threatened to sue?

I am not interested in placing unreasonable restrictions on the permit. This is not just an issue with us, it is an issue of all the surrounding neighborhoods.





RESOLUTION APPROVING CASE UP-88-25, APPLICATION OF JIM FAZZARI

- WHEREAS, Jim Fazzari has applied for a conditional use permit to serve alcoholic beverages after 10:00pm on the site of an approved restaurant located at 475 St. John Street; and
- WHEREAS, zoning for the property is CC (Central Commercial)
 District; and
- WHEREAS, at their duly noticed public hearing of June 22, 1988, the Planning Commission considered all public testimony, relevant exhibits and recommendations of the City staff concerning this application; and
- WHEREAS, the Planning Commission made the following findings:
 - A. That the proposed location of the conditional use is in accordance with the objectives of the zoning ordinance and the purpose of the district in which the site is located.

The subject site is zoned CC (Central Commercial). "Bars" (including restaurants where alcohol is served after 10:00pm) are a conditional use in most subdistricts of the "C" (Commercial) zoning district. One of the purposes of the "C" District is to provide opportunities for amusement establishments for the convenience of the public.

B. That the proposed location of the conditional use and the conditions under which it would be operated or maintained will not be detrimental to the public health, safety, or welfare, or materially injurious to the properties or improvements in the vicinity.

The restaurant would not have an adverse effect on any surrounding properties (commercial or residential) due to the ancillary nature of the alcoholic beverage service relative to the overall restaurant operatio. As conditioned below, the subject location is appropriate for the proposed establishment.

C That the proposed conditional use will comply with each of the applicable provisions of the Municipal Code.

The proposed use will comply with all applicable sections of Chapter 18.124 of the Pleasanton Municipal Code regarding conditional uses; and

WHEREAS, minor alterations in land use limitations are categorically exempt from the requirements of the California Environmental Quality Act.

NOW, THEREFORE, THE PLANNING COMMISSION OF THE CITY OF PLEAS....TON RESOLVES AS FOLLOWS:

- Section 1. Approves Case UP-88-25, application of Jim Fazza.i for a conditional use permit to serve alcoholic beverages after 10:00pm on the site of an approved restaurant located at 475 St. John Street subject to the following conditions:
 - That the use shall conform substantially to the location and details of operation, Exhibit A (dated May 16, 1988), on file with the Planning Department.
 - 2. That if, at any time in the future, the ownership and/or management of the restaurant is unable to control the activities of its patrons such that the presence of the restaurant poses a nuisance to surrounding uses or to the City in general, the Planning Commission may review and, if necessary, attach additional conditions or revoke the subject conditional use permit.
 - 3. That the applicant shall apply for and obtain all applicable City permits for the restaurant establishment prior to the commencement of business.

Section 2. This resolution shall become effective 15 days after its passage and adoption..
