

RESOLUTION NO.**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PLEASANTON, AMENDING THE MASTER FEE SCHEDULE FOR THE PLEASANTON PIONEER CEMETERY**

WHEREAS, the existing fee schedule does not recover actual costs incurred by the City of Pleasanton in all categories; and

WHEREAS, fees must increase beyond the Consumer Price Index to reflect the burial cost increases from the contractors who support the cemetery.

NOW, THEREFORE BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF PLEASANTON DOES RESOLVE, DECLARE, DETERMINE AND ORDER THE FOLLOWING:

SECTION 1. Amends the Master Fee Schedule to:

Burial Plot Fees – South Hill West

Burial Plot – Casket	\$14,450.00
<i>(Includes two (2) rights of Interment, burial services, double vault)</i>	

Burial Plot – Cremated Remains	\$6,130.00
<i>(Includes two (2) rights of interment, two (2) urn vaults)</i>	

Baby Burial Plot – Casket (30 inches or less)	\$4,290.00
<i>(Includes one (1) right of Interment, burial service, single vault)</i>	

Baby Burial Plot – Cremains	\$3,120.00
<i>(Includes one (1) right of Interment, burial service, single urn vault)</i>
