








# Single-Use Foodware



### But Take-out Packaging is Recyclable/Compostable, Right?



### Challenges with "Recyclable" Foodware




Most are not actually recyclable

Tend to end up in the wrong bin

Typically tossed with too much food residue

Possible contamination for fines



### Compostables: Not a Panacea

Most "bioplastics" don't actually decompose

Plastic film contaminates compost

Unhealthy ingredients: PFAS

Polluting production

High cost



# Will it Compost?





### Are compostables the solution?

Fiber-based compostable foodware:

 Thin layer of film plastic "poly-coated paper"


>leads to micro-plastics in soil and water


Grease barriers with perfluorinated compounds

>persist in environment and bioaccumulate in living organisms

#### Reusables in Action

 Honolulu BBQ worked with ReThink Disposable to switch to reusable foodware for onsite dining.

 Okapi is currently working with 10 cafes in the city of Alameda to offer returnable to-go cups.

 Now at the Warfield in SF and coming soon to Alameda County, r.Cup specializes in reusable cups for venues and special events.





## Foodware Policy – The Big Picture

# Goal: Reduce consumption of single-use items!

- Reuse First
- Comprehensive and Innovative
- Modular / Customizable



## Reusables - Required for dine-in, BYO Always Allowed

- Effective 12 months after adoption
- Reusable foodware required for all dine-in establishments
- Waivers available (dishwashing capacity) but expire in the event of a remodel.
- Must accept customer-provided reusables (BYO)
- Vendors operating on City property must comply as well as leases, contracts, etc.









## Disposable Cup and Container Charge

- Effective 12 months after adoption
- Options!
  - Charge for cups only, or add containers
  - \$0.25/disposable item, up to \$1.00
  - \$0.25 flat charge
  - \$0.25 discount for customer BYO
- Business keeps the money
- Includes takeout order/delivery platforms




### **Accessories Only Upon Request**

- Effective Immediately
- Accessories: utensils, napkins, condiment packets, cup sleeves/tops
- Disposables only provided upon request, for take out
- Condiments from bulk dispensers or reusable containers
- Medical exemption upon request
- No bundling!




### Reusable Cups at Venues and Events

- Effective 18 months after adoption
- Reusable cups for all nonpackaged beverages sold
- Attendees can BYO
- Events: at least 25% reusables, ramps up to 50%
- Tracking/Reporting requirement



### **Compliant Disposable Food Ware**

- Effective 12 months after adoption
- Certified free of toxins
- Compostable, third party certified
- Extra: No retail sales of noncompliant foodware



## Polystyrene

- Effective 12 months after adoption
- No sale of polystyrene items:
  - Packing peanuts
  - Styrofoam coolers
  - Pool or Beach toys unless encapsulated
  - Docks/water equipment unless encapsulated
  - Meat, produce trays, egg cartons




### **Waivers and Enforcement**

#### Waiver Process outlined

- Discretion of City
- Not permanent

#### Infractions

- Up to \$100 for first violation
- \$200 for 2<sup>nd</sup> violation
- \$500 subsequent violations (per year)



### StopWaste's Role

- Assist with customization based on local priorities
- Support data analysis and incorporating lessons learned
- Support City Council presentations
- Technical assistance and incentive funding for businesses
- Develop general outreach materials (for countywide use)
- Market development and grant funding to support infrastructure growth

### SB 54 statutory goals



25% of Plastic Packaging cut by 2032



65% of Single-Use Packaging Recycled by 2032



100% Packaging in California Recyclable by 2032
