

**AGREEMENT AUTHORIZING THE MERGER
OF THE CONTRACTS
OF THE
CITY COUNCIL
OF THE
CITY OF PLEASANTON
AND THE
CITY COUNCIL
OF THE
CITY OF LIVERMORE
WITH THE
BOARD OF ADMINISTRATION
PUBLIC EMPLOYEES' RETIREMENT SYSTEM**

- WHEREAS, the City Council of the City of Pleasanton entered into a contract with the Board of Administration, Public Employees' Retirement System, effective September 1, 1953, providing for the participation of their employees in said System; and
- WHEREAS, the City of Livermore shall transfer the fire function to the City of Pleasanton; and
- WHEREAS, Section 20508 of the Government Code authorizes a merger of a portion of a contract for participation in the Public Employees' Retirement System; and
- WHEREAS, service performed for the former agency prior to the effective date of the merger shall be subject to the terms and conditions of the former agency's contract as it was in effect at that time. Service performed after the effective date of this merger shall be subject to the terms and conditions of the successor agency's contract.
- WHEREAS, the Public Employees' Retirement System has proposed an Agreement to be accepted and executed by the governing bodies of the aforementioned public agencies to provide for the merger of a portion of the contract between the City Council of the City of Livermore and the Board of Administration, Public Employees' Retirement System, into the contract between the City Council of the City of Pleasanton and said Board;
- NOW, THEREFORE, BE IT AGREED, that the governing bodies of the aforementioned public agencies authorize, and do hereby authorize, an Agreement between the City of Pleasanton, the City of Livermore and the Board of Administration, Public Employees' Retirement System, to merge a portion of the contract between said Board and the City of Livermore into the contract between said Board and the City of Pleasanton as authorized by Section 20508 of the Government Code; and

BE IT FURTHER AGREED, that the presiding officer of the governing body of each of the
aforementioned contracting agencies is hereby authorized, empowered and
directed to execute said Agreement for and on behalf of the respective agency.
