

**RESOLUTION NO.**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PLEASANTON, AMENDING THE MASTER FEE SCHEDULE FOR THE PLEASANTON PIONEER CEMETERY**

**WHEREAS**, the existing fee schedule does not recover actual costs incurred by the City of Pleasanton in all categories; and

**WHEREAS**, the City of Pleasanton’s contractor fees have increased.

**NOW, THEREFORE BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF PLEASANTON DOES RESOLVE, DECLARE, DETERMINE AND ORDER THE FOLLOWING:**

**SECTION 1.** Amends the Master Fee Schedule to:

<b>Baby Burial Plot – Cremains</b>	<b>\$ 2,850.00</b>
<i>(Includes one (1) right of Interment, burial service, single urn vault)</i>	
<b><u>Burial Services Fee Only</u></b> <i>(With proof of pre-paid plot in Lower Care #1-2, Upper Care #1-2, North Hill, North Hill West, South Hill, Memorial Vista, Sunol Gateway, and Hilltop)</i>
