### 8. MATTERS FOR COMMISSION'S REVIEW/ACTION/INFORMATION

a. Reports from Meetings Attended (e.g., Committee, Task Force, etc.)

No discussion was held or action taken.

#### b. Future Planning Calendar

Beaudin: Accessory Dwelling Units is on the next meeting agenda. There's new state law related to what we in Pleasanton have in our Zoning Code as Second Dwelling Units. So at the next meeting we'll be making changes to the code to maintain some local control over second dwelling units but also remain in compliance with state law. The following meeting, February 8<sup>th</sup>, we'll be looking at a downtown project, 30 West Angela—it's been a shell of a building for too long now so we have new building being proposed at that location. At that meeting we'll also be looking at the Valley Trails project.

Commissioner Ritter: Is that the meeting that two of you will be gone?

Chair Balch: Commissioner Allen and myself will be absent from the February 8<sup>th</sup> meeting.

Commissioner Allen: Tentatively.

# c. Actions of the City Council

Chair Balch: Ratifying appointments to the Task Force was delayed and the acquisition of the SFPUC land was approved. I'd also like to point out that Shweta sent an email notifying us that the Zoning Code Update will be going before Council on January 17.

#### d. Actions of the Zoning Administrator

#### e. Matters for Commission's Information

a. League of California Cities Planning Commissioners Academy

Beaudin: The League of California Cities is hosting a three-day Planning Commissioners Academy in early March. We'd like to see if any members of the Planning Commission are interested in attending. We won't put you on the spot tonight but because there is limited availability we ask that you get back to us by Friday at noon if you're interested in attending. We have resources set aside for this and we hope that we get as many Planning Commissioner's as possible who are interested to attend this. The League of California Cities has put on really well regarded and highly popular Planning Commissioner trainings so it's a great opportunity to compare the Sonoma State experience to this and we'll make some decisions about what we want to offer to the Planning Commission going forward.

Commissioner Ritter: Is there another one throughout the year that's similar to that one if we can't make it in March?

Beaudin: Yes, right at the end of the year we did the Sonoma State Planning Commissioners Academy. That one is also annual; and it's a half-day or about 4-6 hours of content. The League of California Cities version is about two-and-a-half days of content. They're different, certainly, but we encourage any opportunity to get this kind of information and likely we'll have both of them on offer and we just want to make sure we're able to clearly articulate to all of you how they go.

Chair Balch: I would be interested in attending.

Commissioner Brown: So I looked at the agenda for the League of California Cities and it's a lot meatier than Sonoma State's so I'm interested as well. Is there a cost for us?

Beaudin: There would not be a cost for you as far as out of pocket expense. The City has continuing education budget and we do have the money set aside for this kind of training this year.

Commissioner Brown: Thank you.

#### f. Select representatives and alternates for all committees and task forces

a. Overview of Conflict of Interest advice from the Fair Political Practices Commission

Chair Balch: Larissa would you like to make a comment?

Seto: I don't need to elaborate anything on the memo, I'm sure everyone's had a chance to read it.

Chair Balch: Does anyone have interest in serving?

Commissioner Ritter: Should we figure out the Downtown Specific Plan Update Task Force first?

Commissioner Allen: Yes, we should do that first.

Chair Balch: Sounds good. So we know we're limited to the number of people who can participate at this point. There are three who can serve: Commissioner Nagler, Commissioner Brown, and Commissioner Nagler. Are you still not interested in serving?

Commissioner Nagler: Yeah, I think the two of them will do a terrific job.

Commissioner Ritter: Would you be the alternate? I think that's what we're looking for.

Commissioner Nagler: I very much appreciate the City Attorney's office continuing to help clarify whether there is in fact a conflict on Commissioner Allen's part. And obviously we heard back that staff attorney at the FPPC continues to believe there is a conflict and there's nothing for us to do but accept it. I continue to believe that the exception in the law is there for a reason and in fact is applicable but the answer is the answer. And as far as the alternate goes I would be willing to serve as the alternate until such time as Commissioner Allen is cleared of the conflict if such time occurs at which time she would become the alternate.

Chair Balch: so may I suggest we make it clean and then if that time arises we reagendize the item.

Commissioner Ritter moved to appoint Commissioners Brown and Ritter as representatives and Commissioner Nagler as alternate to the Downtown Specific Plan Update Task Force.

Commissioner Allen seconded the motion.

Commissioner Allen: Given that I'm not on the Downtown Task Force I am still interested in serving on the BPTC, if no one else has an interest, if someone else has an interest though I'm also open to yielding that position.

Commissioner Ritter: I don't mind being an alternate if that's an option. I like going to those meetings.

Commissioner Allen: And just an FYI, there's about a third of those meetings I cannot make because I will be out of town so the alternate really is important.

Commissioner Ritter: Ok.

Commissioner Nagler moved to appoint Commissioner Allen as representative and Commissioner Ritter as alternate to the Bicycle, Pedestrian, and Trails Committee.

Commissioner O'Connor seconded the motion.

Commissioner Allen: I'd like to serve unless somebody else wanted to, strongly.

Commissioner O'Connor: Same here.

Chair Balch: I'd be fine being alternate.

Commissioner Nagler moved to appoint Commissioners Allen and O'Connor as representatives and Commissioner Balch as alternate to the Heritage Tree Board of Appeals.

Commissioner Ritter seconded the motion.

Beaudin: I don't know if it's always in March but it's an annual conference.

Commissioner O'Connor: I also can't make that date.

Commissioner Nagler: I need to check the dates and get back to you.
