a. P18-0253, Haranath Gnana/Sri Sai Temple

Application for Conditional Use Permit to operate a religious facility within an existing building for Sri Sai Temple at 3940 Valley Avenue. Zoning for the property is Planned Unit Development – Industrial (PUD-I) District.

Commissioner Allen moved to approve the Consent Calendar. Commissioner Ritter seconded the motion.

6. PUBLIC HEARING AND OTHER MATTERS

a. P18-0240 and P18-0241, Nachi Periakaruppan/Safari Kid

Applications for Conditional Use Permit and Design Review approvals to operate a heritage school and preschool with an outdoor playground for Safari Kid at 4464 Willow Road. Zoning for the property is PUD-I/C-O (Planned Unit Development-Industrial/Commercial-Office) District.

Associate Planner Jennifer Hagen presented the agenda report.

Commissioner Ritter asked staff if there have been any objections to the application. Ms. Hagen replied that staff has not received any comments or concerns.

Commissioner Allen asked if this school is the largest preschool/heritage school currently in the City. Mr. Beaudin replied that this is among the largest.

Commissioner Allen stated that the only potential risk factor she sees is the traffic circulation, but that it appears that Safari Kid should manage it well, using Inglewood Drive as the entry. She stated that if the application is approved, the school needs to be accountable to ensuring the parents cooperate with the traffic flow.

THE PUBLIC HEARING WAS OPENED.

Wayne Renshaw, the applicant's architect, stated that Safari Kid has been around for 5 years. Due to high demand, they are essentially doubling in size. He mentioned that there are 111 parking spaces allocated to Safari Kid, which is far more than the 70 required per the zoning code.

THE PUBLIC HEARING WAS CLOSED

Commissioner Allen moved to approve Cases P18-0240 and P18-0241. Commissioner Ritter seconded the motion.
