#### CALL TO ORDER

The Planning Commission Meeting of June 26, 2013, was called to order at 7:00 p.m. by Chair Jennifer Pearce.

Application for Conditional Use Permit to operate a martial arts studio in an existing building located at 6668 Owens Drive. Zoning for the property is PUD-I/C-O (Planned Unit Development – Industrial/Commercial-Office) District.

Chair Pearce nominated Commissioner Ritter to replace Commissioner Narum on the East Pleasanton Specific Plan Task Force. Commissioner O'Connor seconded the motion.

Commissioner Ritter indicated that he would be honored to serve on the Task Force and that he is already honored serving as an Alternate of the Parks and Recreation Commission. He stated that he thinks it would be a good fit as he has no bias in that area since he lives on other side of town. As a side note, he added that having Commissioner Allen on the Task Force prior to her appointment to the Planning Commission is good as she has an understanding of the Task Force, and together with Chair Pearce who is also on the Task Force, this would help the Planning Commission in the process. He accepted the nomination, indicating that the Task Force is a good group.
