# CALL TO ORDER

The Planning Commission Meeting of April 11, 2012, was called to order at 7:00 p.m. by Chair Jerry Pentin.

# 2. <u>APPROVAL OF MINUTES</u>

#### a. March 14, 2012

Chair Pentin noted that he had earlier requested Ms. Hoey to make a couple of typographical changes.

#### 5. <u>CONSENT CALENDAR</u>

a. P11-0798, Archie G. Perlegos

Application for Design Review approval to construct an approximately 4,232-square-foot single-story home and an 866-square-foot attached garage at 5982 Kolb Ranch Drive (Lot 9). Zoning for the property is PUD-LDR/OS (Planned Unit Development – Low Density Residential/ Open Space) District.

Commissioner Blank moved to approve Case P11-0798, subject to the Conditions of Approval listed in Exhibit A of the staff report. Commissioner Narum seconded the motion.

# 6. PUBLIC HEARINGS AND OTHER MATTERS

 a. <u>P12-0054, Leon Yuan, Academic Center of Volitation</u> Application for a Conditional Use Permit to operate a heritage school for 80 Kindergarten through 8<sup>th</sup> Grade students in an existing building located at 5200 Franklin Drive, Suite 110. Zoning for the property is PUD-I/C-O (Planned Unit Development – Industrial/Commercial-Office) District.

Jenny Soo presented the staff report and described the layout, scope, and key elements of the project. She noted that just before the meeting, the applicant had indicated that the school has already submitted to the California Department of Education, its request for registration to relocate to Pleasanton and to increase the number of students and that the school should be getting its registration approved shortly.

Commissioner Pearce requested clarification regarding Ms. Soo's statement regarding the school acquiring State registration and inquired if the school is not currently registered as a heritage school.

Ms. Soo clarified that the school is currently registered as a heritage school; however, it needs to update its registration due to its application to relocate from Dublin to Pleasanton and to increase its enrolment.

Commissioner Narum inquired if the Conditions of Approval for this proposal is similar to those of Little Ivy League, the heritage school earlier approved by the Commission.

Ms. Soo said yes.

Commissioner O'Connor inquired if there were any conditions that were added or deleted from those approved for Little Ivy League and if there was anything special or different about this site.

Ms. Soo replied that the only difference is that this project is also proposing a PUD Minor Modification, and, therefore, approval of the Conditional Use Permit is subject to the approval of the PUD Minor Modification.

#### THE PUBLIC HEARING WAS OPENED.

There were no speakers.

#### THE PUBLIC HEARING WAS CLOSED.

Commissioner Blank moved to make the required conditional use findings as described in the staff report and to approve Case P121-0054, subject to the Conditions of Approval listed in Exhibit A of the staff report. Commissioner Narum seconded the motion.

# 9. <u>COMMUNICATIONS</u>

Commission Narum advised that the Downtown Hospitality Task Force is getting down to the end and noted that at its last meeting, the Task Force approved a core area that would be allowed to operate up to 11:00 p.m. without requiring a Conditional Use Permit, and a transitional area that can operate until 10:00 p.m. She added that there was discussion on relaxing the Noise Ordinance a bit which should be done within a month or so and will be coming before the Planning Commission for review. She indicated that it would be interesting to see how this progresses because while the Task Force is making progress, it is not unanimous to date.

Chair Pentin indicated that the Task Force has two more meetings scheduled for May 3, 2012 and May 31, 2012 and should be done by then. He noted that Commissioner Narum called it the Downtown Hospitality Task Force, but it is the Downtown Hospitality Guidelines Task Force. He pointed out that the Task Force is working on Guidelines, and this word is sometimes dropped in discussions. He added that he hopes that he and Commissioner Narum will have something good to report in another month.

Commissioner Narum agreed that "Guidelines" is important. She added that the Task Force will have had a total of four extra meetings
