## PROFESSIONAL SERVICES AGREEMENT

THIS PROFESSIONAL SERVICES AGREEMENT ("Agreement") is entered int

("City	"), and Rincon	Consultants, Inc., a (California corporation) whose address is 449 15 <sup>th</sup>			
Street	. Suite 303, Oal	kland, CA 94612, and telephone number is (510) 831- 4455, ("Consultant").			

#### RECITALS

- A. Consultant is qualified to and experienced in providing on-call environmental review services on an as-needed basis for purposes specified in this Agreement.
- B. City finds it necessary and advisable to use the services of the Consultant for the purposes provided in this Agreement.

**NOW THEREFORE**, in consideration of the mutual covenants and conditions in this Agreement, City and Consultant agree as follows:

- 1. <u>Consultant's Services</u>. Subject to the terms and conditions set forth in this Agreement, Consultant shall provide to City the services and furnish the materials, reports and drawings related to the preparation of environmental review documents pursuant to California Environmental Quality Act (CEQA) and its Guidelines, as hereinafter set forth:
  - a. Consultant shall perform all work described in the Scope of Work which will be submitted prior to authorization to proceed on individual projects.
  - b. Consultant shall meet with staff of the City, other pertinent agencies, and/ or landowners as necessary to complete the scope of work outlined in Section 1 (a) above.
  - c. The City reserves the right to select other consultants for services based on City needs.
- 2. <u>City Services</u>. In order to assist Consultant in this work, City shall provide, if necessary, relevant application materials and related reports, any existing plans of the area on file, necessary direction, and review of consultant-submitted draft materials within a reasonable time. Other City services shall be as mutually agreed to by the City and consultant as part of an authorized Scope of Work.
- 3. <u>Staff.</u> The Project Manager for Consultant shall be Abe Leider, who may not be replaced without written consent of City.
- 4. <u>Sufficiency of Consultant's Work</u>. All reports, documents, drawings, plans and specifications prepared for City shall be adequate and sufficient to meet the purposes for which they are prepared.
- 5. Ownership of Work. All final reports, documents, drawings, plans and specifications, maps, designs, work data, and all other documents completed by Consultant in the performance of this Agreement shall become the property of City.

- 6. <u>Terms</u>. The term of the agreement shall commence on the date written above and shall expire on June 30, 2024, with up to two additional one-year extensions. Work authorizations issued by the City prior to the expiration of the term of this Agreement may be completed by Consultant after the term of this Agreement.
- 7. <u>Compensation</u>. For the as-needed services to be rendered, City shall pay consultant on time-and-materials based on the rate schedule per Exhibit A, which is attached and incorporated into this Agreement. Exhibit A may be amended on an annual basis at the start of the new fiscal year (July 1, 2021, July 1, 2022, and July 1, 2023). Individual projects covered by this contract shall require separate proposals and shall not exceed the cost estimate submitted. Partial payment shall be made on a monthly basis in proportion to the percentage of work completed, upon receipt of Consultant's invoice.
- a. Invoices submitted to City for payment must contain a brief description of work performed, percentage of work completed, percentage of contract time used, percentage of contract amount expended and City reference numbers: Account No., Contract No., and Project No. Payment shall be made within thirty (30) days of receipt of Consultant's invoice.
- b. Upon completion of work and acceptance by City, Consultant shall have ninety (90) days in which to submit final invoicing for payment. An extension may be granted by City upon receiving a written request thirty (30) days in advance of said time limitation. The City shall have no obligation or liability to pay any invoice for work performed which the Consultant fails or neglects to submit within ninety (90) days, or any extension thereof granted by the City, after the work is accepted by the City.
- 8. <u>Changes</u>. City may request changes in the scope of services to be provided by Consultant. Any changes and related fees shall be mutually agreed upon between the parties and subject to a written amendment to this Agreement.
- 9. <u>Consultant's Status</u>. In performing the obligations set forth in this Agreement, Consultant shall have the status of an independent contractor and Consultant shall not be considered to be an employee of the City for any purpose. All persons working for or under the direction of Consultant are its agents and employees and are not agents or employees of City.
- 10. <u>Termination for Convenience of City</u>. The City may terminate this Agreement at any time by mailing a notice in writing to Consultant. The Agreement shall then be deemed terminated, and no further work shall be performed by Consultant. If the Agreement is so terminated, the Consultant shall be paid for that percentage of the work actually completed at the time the notice of termination is received.
- 11. <u>Non-Assignability</u>. The Consultant shall not assign, sublet, or transfer this Agreement or any interest or obligation in the Agreement without the prior written consent of the City, and then only upon such terms and conditions as City may set forth in writing. Consultant shall be solely responsible for reimbursing subcontractors.
- 12. <u>Indemnity and Hold Harmless</u>. Consultant shall defend, indemnify, and hold harmless, the City and its officers, agents and employees from and against all claims, losses, damage, injury, and liability for damages arising from, or alleged to have arisen from, errors, omissions, negligent or wrongful acts of the Consultant in the performance of its services under this

Agreement, regardless of whether the City has reviewed or approved the work or services which has given rise to the claim, loss, damage, injury or liability for damages. This indemnification shall extend for a reasonable period of time after completion of the project as well as during the period of actual performance of services under this Agreement. The City's acceptance of the insurance certificates required under this Agreement does not relieve the Consultant from its obligation under this paragraph.

- 13. <u>Insurance</u>. During the term of this Agreement, Consultant shall maintain in full force and effect, at its own cost and expense, insurance coverages with insurers with an A.M. Best's rating of no less than A:VII. Contractor shall have the obligation to furnish City, as additional insured, the minimum coverages identified below, or such greater or broader coverage for City, if available in the Contractor's policies:
- a. General Liability and Bodily Injury Insurance. Commercial general liability insurance with limits of at least \$2,000,000 combined limit for bodily injury and property damage that provides that the City, its officers, employees and agents are named as additional insureds under the policy as evidenced by an additional insured endorsement satisfactory to the City Attorney. The policy shall state in writing either on the Certificate of Insurance or attached rider that this insurance will operate as primary insurance for work performed by Consultant and its subconsultants, and that no other insurance effected by City or other named insured will be called on to cover a loss.
- b. <u>Automobile Liability Insurance</u>. Automobile liability insurance with limits not less than \$2,000,000 per person/per occurrence.
- c. <u>Workers' Compensation Insurance</u>. Workers' Compensation Insurance for all of Consultant's employees, in strict compliance with State laws, including a waiver of subrogation and Employer's Liability Insurance with limits of at least \$1,000,000.
- i. <u>Professional Liability Insurance</u>. Professional liability insurance in the amount of \$2,000,000.
- ii. <u>Certificate of Insurance</u>. Consultant shall file a certificate of insurance with the City prior to the City's execution of this Agreement, and prior to engaging in any operation or activity set forth in this Agreement. The Certificate of Insurance shall provide in writing that the insurance afforded by this Certificate shall not be suspended, voided, canceled, reduced in coverage or in limits without providing notice to the City in accordance with California Insurance Code section 677.2 which requires the notice of cancellation to: 1) include the effective date of the cancellation; 2) include the reasons for the cancellation; and 3) be given at least 30 days prior to the effective date of the cancellation, except that in the case of cancellation for nonpayment of premiums or for fraud, the notice shall be given no less than 10 days prior to the effective date of the cancellation. Notice shall be sent by certified mail, return receipt requested. In addition, the <u>insured</u> shall provide thirty (30) days prior written notice to the City of any cancellation, suspension, reduction of coverage or in limits, or voiding of the insurance coverage required by this agreement. The City reserves the right to require complete certified copies of policies.
- e. <u>Waiver of Subrogation</u>. The insurer agrees to waive all rights of subrogation against the City, its officers, employees and agents.

- f. <u>Defense Costs</u>. Coverage shall be provided on a "pay on behalf of" basis, with defense costs payable in addition to policy limits. There shall be no cross liability exclusions.
- g. <u>Subcontractors</u>. Consultant shall include all subcontractors as insured under its policies or shall furnish separate certificates and endorsements for each subcontractor. All coverages for subcontractors shall be subject to all of the requirements stated in this Agreement, including but not limited naming additional insureds.
- 14. <u>Notices</u>. All notices herein required shall be in writing and shall be sent by certified or registered mail, postage prepaid, addressed as follows:

- 15. <u>Conformance to Applicable Laws</u>. Consultant shall comply with all applicable Federal, State, and Municipal laws, rules, and ordinances. Consultant shall not discriminate in the employment of persons or in the provision of services under this Agreement on the basis of any legally protected classification, including race, color, national origin, ancestry, sex or religion of such person.
- 16. <u>Licenses, Certifications and Permits</u>. Prior to the City's execution of this Agreement and prior to the Consultant's engaging in any operation or activity set forth in this Agreement, Consultant shall obtain a City of Pleasanton business license, which must be kept in effect during the term of this Agreement. Consultant covenants that it has obtained all certificates, licenses, permits and the like required to perform the services under this Agreement.
- 17. **Records and Audits**. Consultant shall maintain all records regarding this Agreement and the services performed for a period of three years from the date that final payment is made. At any time during normal business hours, the records shall be made available to the City to inspect and audit.
- 18. <u>Confidentiality</u>. Consultant shall exercise reasonable precautions to prevent the unauthorized disclosure and use of City reports, information or conclusions.
- 19. <u>Conflicts of Interest</u>. Consultant covenants that other than this Agreement, Consultant has no financial interest with any official, employee or other representative of the City. Consultant and its principals do not have any financial interest in real property, sources of income or investment that would be affected in any manner of degree by the performance of Consultant's services under this Agreement. If such an interest arises, Consultant will immediately notify the City.
- 20. <u>Waiver</u>. In the event either City or Consultant at any time waive any breach of this Agreement by the other, such waiver shall not constitute a waiver of any other or succeeding breach of this Agreement, whether of the same or of any other covenant, condition or obligation.

- 21. <u>Governing Law</u>. California law shall govern any legal action pursuant to this Agreement with venue in the applicable court or forum for Alameda County.
- 22. **No Personal Liability**. No official or employee of City shall be personally liable to Consultant in the event of any default or breach by the City or for any amount due Consultant.
- 23. **Exhibits**. All exhibits referred to herein are attached hereto and are by this reference incorporated herein.
- 24. <u>Counterparts and Electronic Signatures</u>. This Agreement may be executed in multiple counterparts, each of which shall be an original and all of which together shall constitute one agreement. Counterparts may be delivered via facsimile, electronic mail (including pdf or any electronic signature complying with U.S. federal E-Sign Act of 2000 (15 U.S. Code §7001 et seq.), California Uniform Electronic Transactions Act (Cal. Civil Code §1633.1 et seq.), or other applicable law) or other transmission method, and any counterpart so delivered shall be deemed to have been duly and validly delivered and be valid and effective for all purposes.
- 25. <u>Scope of Agreement</u>. This writing constitutes the entire Agreement between the parties. Any modification to the Agreement shall be in writing and signed by both parties.



The CEQA process commonly involves review of documents, attending meetings with the lead agency and project applicant, interacting with regulatory agencies, preparation of reports, and attending public meetings and hearings. This commonly starts with a review of the CEQA Guidelines to assess whether a project is exempt from more detailed environmental review. Exemptions are relatively well defined in the Guidelines and include the categories of projects that would not likely result in significant environmental effects (such as repairs or replacements of existing facilities, infill development, etc.). If not exempt, we would complete an Initial Study Checklist to determine the appropriate environmental clearance document. For projects where all impacts can clearly be mitigated and where there is not a strong base of public controversy, a ND or MND is prepared. Projects that may result in a significant environmental impact typically require an EIR. When an EIR is required, we utilize the IS and scoping process to focus the document on impacts that have the potential to result in significant impacts.

In addition to assisting our clients with the CEQA process, our environmental planning group also regularly prepares a broad range of technical studies (such as air quality, noise, biology, and cultural resources) to help design teams develop projects that avoid or minimize significant environmental effects. Our project management team is highly adept at coordinating and managing the work between various disciplines as required. Rincon also supports with the development and implementation of mitigation monitoring and reporting programs, including revegetation and habitat restoration that may be required through the environmental planning process.

# 1.2 Peer Review of Applicant Assessments

Rincon provides technical peer review services for public agencies throughout California. Our technical experts will peer review applicant-provided technical reports and supporting documentation submitted. These reviews are anticipated to include air quality/greenhouse gas emissions studies, health risk assessments, biological resources and cultural resources evaluations, Phase I environmental site assessments, and noise analyses, among others. Rincon prepared a Community Plan Consistency Checklist Pursuant to CEQA Guidelines Section 15183 for the 3716 Stanley Boulevard Public Storage Project. The project would redevelop a portion of an existing self-storage facility with a new self-storage facility. The existing site contains 14 single-story, storage buildings, an attached office, and a parking storage lot. The

project would remove seven of the eastern storage buildings (39,774 square feet), the existing 1,281-square foot office building, and the storage parking lot. These would be replaced with one single-story storage building, one three-story storage building, and a new office building. The new one-story building would be 9,750 square feet and would be accessed from a common lobby. The proposed three-story building would be 194,377 square feet, with a 66,974-square foot footprint. The project applicant is proposing to contribute funding to construct a portion of a trail on the south side of Nevada Street, adjacent to the Arroyo del Valle riparian corridor. The trail and necessary improvements would be implemented as a separate independent project as the proposed project would only provide partial funding for the trail and would not construct it. Upon comprehensive project review, Rincon found that pursuant with CEQA Guidelines Section 15183, the project would be consistent with a Community Plan or Zoning, that there would be no project-specific significant effects which are peculiar to the project or its site, and therefore no additional environmental review was required.


