

**FOURTH AMENDMENT TO AGREEMENT**

This Fourth Amendment to Agreement ("Fourth Amendment") is entered January 1, 2020 by the City of Pleasanton ("City") and Monte Vista Memorial Investment Group (MVMIG), LLC, a Limited Liability Corporation whose address is 3656 Las Colinas Road, Livermore, CA 94551, and telephone number is 408-499-2197 ("Contractor").

**Whereas**, City and Contractor entered into an Agreement for Burial Services, Marker Installation, and Ground Maintenance services on December 7, 2016, as amended by the First Amendment dated November 17, 2017, the Second Amendment dated December 27, 2017, and the third amendment dated February 5, 2019 (collectively the "Agreement"); and

**Whereas**, Section 3 of the Agreement allows the parties to extend the term; and

**Whereas**, the parties desire to further amend the Agreement.

Now, therefore, in exchange for valuable consideration, the receipt of which is hereby acknowledged, the parties agree as follows:

1. Section 3. of the Agreement, "Terms" is amended to read: "The contract shall commence on January 1, 2017 and shall expire on January 31, 2020. The City and Contractor shall retain the right to renew this Agreement."
2. Exhibit A, Section 3. of the Agreement, "Scope of Consultants Services" Burial Services and Grounds Maintenance" is amended to read:


Other than amended above, the Agreement remains in full force and effect.


